IT is hereby notified that the Minister of Justice, Legal and Parliamentary Affairs, in terms of section 57 of the High Court of Zimbabwe Act, 1981, has made the following regulations -

1.

- (1) These regulations may be cited as the High Court (Fees) (Civil Cases) Regulations, 1992.
- (2) These regulations shall come into operation on the 1st January, 1993.

For any matter referred to in [the Schedule](#), the appropriate fee specified therein shall be payable.
